For the reasons stated on the record on April 20, 2010, and for good and sufficient cause shown, it is hereby

ORDERED that the Countrywide Defendants shall produce to Plaintiff Syncora the loan origination files for all of the loans in the following three securitizations originated by Countrywide and insured by Syncora: CWABS Revolving Home Equity Loan Trust Series 2004-Q; CWABS Revolving Home Equity Loan Trust Series 2004-R; and CWHEQ Home Equity Loan Trust, Series 2006-S7 (the "Loan Files"); and

IT IS FURTHER ORDERED that documents responsive to both parties' pending document requests shall be produced on or before June 1, 2010; and

IT IS FURTHER ORDERED that all parties shall appear before the Court for the next compliance conference on May 18, 2010. The dates set forth herein may not be adjourned except with approval of the Court.

Pursuant to an agreement between the parties it is hereby

ORDERED that the Countrywide Defendants shall produce all of the Loan Files on or before June 30, 2010. The Countrywide Defendants shall use best efforts to produce the Loan Files on a rolling basis, beginning with the Loan Files for the non-performing loans in 2006-S7, and shall use best efforts to make the first rolling production on or before May 14, 2010. The Countrywide Defendants shall use best efforts to produce the Loan Files for all non-performing (180 or more days delinquent) loans on or before May 31, 2010.
